For this reason, the VR BAR Company feels confident in offering a 2 year limited warranty

WARRANTY LIMITATIONS

The VR BAR Company will repair or replace (*at our discretion*) the VR BAR with new or refurbished parts for a period of two years from the date of purchase. Such work will be performed free of charge. No Product may be returned directly to The VR BAR Company without first contacting us for a Return Material Authorization ("RMA") number. If it is determined that the VR BAR may be defective, you will be given an RMA number and instructions for the return. Please see the complete Return Authorization Policy (RMA) below.

Proof of date of original purchase will be required before warranty performance is rendered. This warranty is extended only to the original purchaser and is not transferable.

This warranty only covers failures due to defects in materials or workmanship which occur during normal use. It does not cover damages or failures which are caused from misuse, abuse, modification, accident, neglect, alteration, or service by anyone other than The VR BAR Company.

WARRANTY EXCLUSIONS

There are no express warranties except as listed above.
